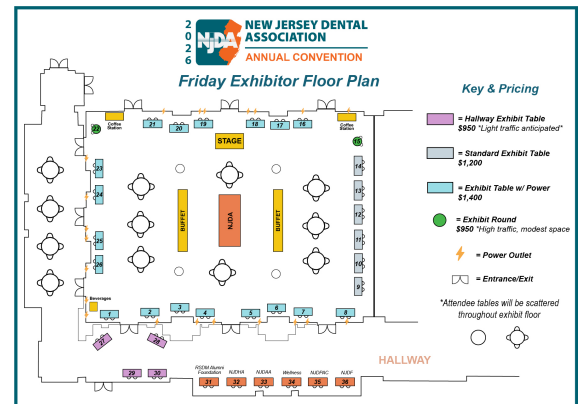


Exhibit Space Assignments

- Exhibitor tables will be assigned on a first come first served basis.
- Access to power outlets is labeled on the floor plan to help exhibitors choose their table accordingly.
- Payment must be submitted in full at the time of booking. In the event of a cancellation, any monies paid to NJDA will be refunded only if all exhibit space is sold. Refunds will be made following the conference. Cancellations within 45 days of the conference will not be refunded.
- Exhibitors will receive a 6' table. Booths are not available.
- All exhibit personnel must be registered with conference management and wear a name badge while in the exhibit space.
- Each exhibit table allows for a maximum of two (2) company representatives. Only one company per table: no shared exhibit spaces.

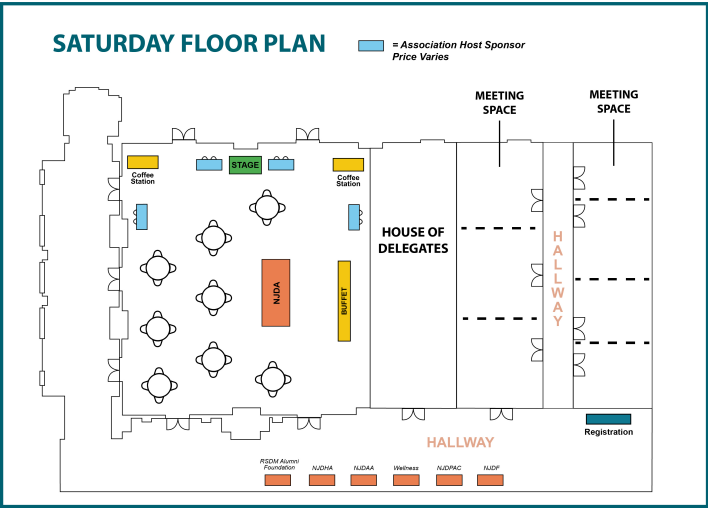
